

## PROJECT FINANCIAL BREAKDOWN

Proposed Cost: \$6.7M

Building Aid Ratio: 86.8%

• Capital Reserve Funds: \$1M (Still Remaining Funds)


# **Q:** How will you address concerns about sound and acoustics issues when moving the performing arts spaces to the main building?

**A:** This is a common and a successful setup in numerous other school districts. Our experienced architects along with their specialized acoustical consultants have a deep understanding of how to design buildings to minimize sound transfer between different areas. They will use a variety of techniques such as strategically locating the performance spaces, using sound-absorbing materials, and creating buffers like practice rooms and corridors to reduce noise bleed.

### **Q:** The band room and science classroom renderings look like the project is already designed. Will you engage the teachers and staff on the final design?

**A:** Absolutely! While they provide a general idea of the project's scope and intent, they do not represent the final design. If the referendum is approved, we will engage in a robust process with key stakeholders, including staff, to shape the ultimate design of the spaces.

#### WHO CAN VOTE?

According to New York Education Law, in order to vote, you must be: A citizen of the United States; 18 years of age; and a resident of the district for at least 30 days. You do not have to be registered to vote. You do NOT have to own property in the district, but you MUST reside in the district. Identification and proof of residence WILL be requested at the time of voting.

#### **PROPOSITION**

Shall the Board of Education be authorized to undertake a capital improvement project consisting of renovations, alterations, improvements and upgrades to District's main K-12 building and Annex Building, all to include site work, utility, mechanical, plumbing, electrical, masonry and roofing improvements; miscellaneous infrastructure upgrades; furnishings, fixtures and equipment required for such purposes; architectural/engineering and other professional services fees; and all other costs incidental to such work, at a total estimated cost not to exceed \$6,700,000 and to pay for such project by using \$1,000,000 from the District's Capital Reserve and, for the balance, by the levy of a tax which is hereby voted in the amount of \$5,700,000, subject to available State aid or to any other revenues available for such purpose, which tax shall be levied and collected in annual installments in such years and in such amounts as may be determined by the Board of Education and in anticipation of the collection of such tax, bonds and notes of the District are hereby authorized to be issued at one time, or from time to time, in the principal amount not to exceed \$5,700,000, and a tax is hereby voted to pay the principal and interest on said obligations when due?

\*Please note the above proposition language states "by the levy of a tax..." but the capital project will have <u>no additional tax impact</u>. Legally, the District must bond the project and include this language in the proposition but by strategically timing the payments along with New York State building aid and other finanical strategies, there will be no additional tax impact.
